#### CONTEXT AND BACKGROUND

Vision 2021 aims for a safe and secure nation by implementing a fair legal system where all citizens, residents, and visitors feel safe and encouraged to claim their rights; becoming a global leader.

Since its formation, the UAE has supported the international pursuit of peace, security, and development. With diplomatic relations with 189 countries and 110 foreign embassies, 73 consulates and 15 regional and international organizations in the UAE.

According to the Global Competitiveness Report 2015-2016, the UAE is 1st globally in the least cost to business costs in terms of crime and violence and 2nd on citizens' confidence in government and leadership.

### **NEED**

Trust in government is the cornerstone of good governance; without it, a country cannot properly develop its economy, have the support of its people, or be seen as a credible partner to other countries.

### **Mohammed bin Rashid Smart Council**

H. H. Sheikh Mohammed bin Rashid Al Maktoum launched Mohammed Bin Rashid Smart Majlis, which connects 30 government entities in Dubai and operates under his direct supervision. The smart majlis allows people from various segments of society to interact and participate in the development process of the country by presenting their ideas and comments to the Majlis as well as answering the questions posed by His Highness; just like if they were attending the traditional majlis with him.

### Transparency in the UAE

Trust between a government and its people is critical to the peaceful stability of a country. The UAE is no different and has implemented a good governance program that strongly supports transparency in terms of providing online services, data, knowledge, and encouraging e-participation. It has long championed ethical behavior and has some of the toughest legislation against corruption and bribery.



The UAE has implemented a powerful audit programme that ensures that its financial resources and budget are allocated fairly and holds all institutions accountable for their expenditures. This has led to a high percentage of Emiratis having great trust in the government and its institutions.

The UAE supports strong and transparent values in its institutions, which are reflected in the following laws and institutions with the UAE:

- No Corruption or bribery: The UAE does not tolerate corruption in any way and makes everyone accountable for such deeds, both in the private or public sector.
- Articles 234-239 of the UAE Penal Code sets out for people in public office legal provisions for anti-bribery and corruption.
- State Audit Institution (SAI) is the supreme audit authority in the UAE; it is in charge
  of protecting government funds and ensuring that they are allocated and spent
  within the laws and regulations. As well as overseeing fighting fraud and corruption
  in the government; welcoming the public to reporting of any suspected fraud.

# **Public tendering processes**

The government facilitates a fair and secure tendering process for businesses, ensuring all registered suppliers can trade with government businesses on a fair and equal basis.

UAE government offers online tendering services to facilitate a transparent process. These include:

# **Government protection of people's identity**

Due to the continuing threat of terrorism and rising cases of credit card fraud, identity protection has become a key concern globally.

Federal Authority for Identity and Citizenship (ICA), earlier known as Emirates Identity Authority (EIDA) completed the launch of electronic identity cards for the whole population inclusive of nationals and residents. The card carries biometric details of the holders, in order to verify and confirm the identity of each through a personal number and a smart card related to the biological features.

Forgetting an Emirates ID card, the applicant has to fill the eForm in one of the authorized typing centers or through the Emirates ID online form available on its website. An SMS containing information about when and where to register will follow the application. The applicant will proceed afterward to the registration center mentioned in the SMS to complete the procedures.

You might need to visit an Emirates ID service center or preventive medical center to provide your biometric details. Refer to the ICA's website for the application process, documents required and fees for getting an Emirates ID for:

- UAE nationals
- GCC nationals residing in the UAE
- Residents.

The UAE Government adopted the Open Data policy to make government data and information accessible to the public. Federal (FCSA), is the UAE government source for national statistics in all sector as well as the responsible for making open data and publications available to the public on their portals online.

In order to ensure that UAE's diversity remains a strength and magnet to continue to attract the best and brightness, the government has enacted specific laws to protect vulnerable groups.

# The federal law against hatred and discrimination

Federal Decree Law No. 2 of 2015 on Combating Discrimination and Hatred (PDF) criminalizes any acts that promote religious hatred through any form of expression. It



makes it illegal to discriminate against individuals or groups based on religion, caste, doctrine, race, color, or ethnic origin. Violators will be exposed to penalties, which include jail terms and fines. The law encourages anyone involved in any activity that violates the law to submit themselves before the authorities voluntarily and has provisions allowing the courts to waive penalties in such cases.

# **National Tolerance Program**

UAE's National Tolerance Program was launched in collaboration with federal and local government entities. The Program has five main themes:

- 1) Strengthen government's role as an incubator of tolerance,
- 2) Consolidate the role of the family in nation-building,
- 3) Promote tolerance among young people and prevent them from fanaticism and extremism.
- 4) Enrich scientific and cultural content,
- 5) Integrate international efforts to promote tolerance and highlight the leading role of UAE in this area.

The post of the Minister of State for Tolerance was first established in 2016 when H.H. Sheikh Mohammed bin Rashid Al Maktoum, Prime Minister and Vice-President of the UAE and Ruler of Dubai, announced the structural changes to the Cabinet. Reinforcing the UAE's commitment to eradicating ideological, cultural, and religious bigotry in society; Sheikha Lubna Al Qasimi was the first Minister of State for Tolerance. In 2017, His Excellency Sheikh Nahyan bin Mubarak Al Nahyan was appointed as Cabinet member and the Minister of State for Tolerance in the UAE.

### **IMPACT**

With more than 200 nationalities living peacefully and successfully in the UAE, its society has been an exemplary example of a tolerant and inclusive country. Now, the Federal Government is keen to promote acceptance and understanding as core values of the society.



The population of the UAE continues to increase with a constant influx of expatriates and the UAE government is continuing to build more cities to accommodate this influx, which has led to economic growth and greater employment opportunities.
