

## **Crowdsourcing to Enhance Content**

### **Enhancing the content of the official portal of the UAE through crowdsourcing**

#### **The story so far...**

Government.ae is the official portal of the UAE Government and a one-stop shop to access information and services of the UAE Government. It was launched in May 2011. The portal plays an important role in deciding a country's position in the UN's biennially released report on eGovernments across the world. The UAE has consistently been amongst the top rankers in the eGovernment Development Index not only in GCC but also in the MENA region.

#### **An idea was born**

The portal is maintained and constantly updated by Telecommunications Regulatory Authority. In April 2018, TRA decided to enhance the content of the portal by applying crowdsourcing. Thus, a campaign to enhance the content of the official portal of the UAE through crowdsourcing was launched.

The purpose of the campaign is to:

- position Government.ae as a main source of information on the UAE government
- engage public in building content on the portal
- enrich the content on the federal portal
- encourage the practice of eParticipation and
- encourage other government entities to review their related parts on the portal.

#### **The campaign**

TRA conducted several brainstorming sessions to figure out the best strategy until we designed the campaign. A short survey was prepared asking the public to point out missing/incomplete/wrong information on the portal. The public was also invited to suggest topics to be added on the portal. This survey was propagated largely through the official social media accounts of the UAE mGovernment. A hashtag ParticipateAndGetAReward was coined specially for this purpose. Prizes through a raffle draw were announced to those who contributed. Yet, the response was low.

#### **Change in strategy**

TRA considered the low response and devised a change in approach. The survey was shortened to retain crowd patience and interest. The A pop-up was introduced on the portal, encouraging people to take part in the survey. These brought a huge change in the number of responses received.

#### **Huge response**

In July, we received more than 3,000 responses in English and Arabic. Most of the responses were related to jobs, visa and VAT.

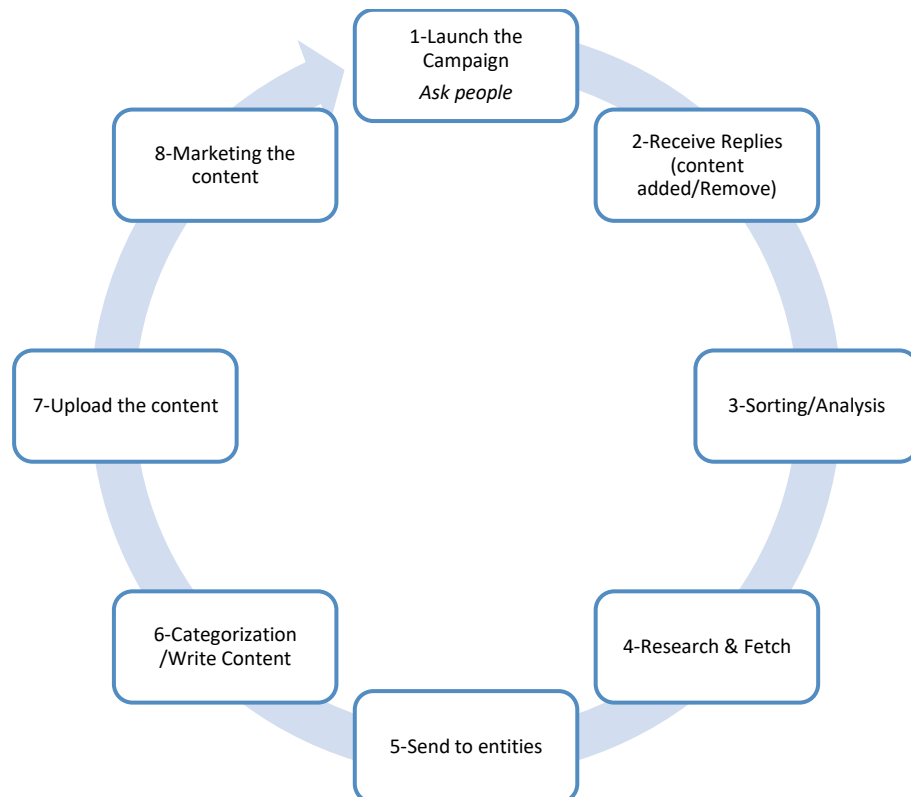
### The next steps

After the team receives the responses, it sorts them first on the basis of utility. Then, the responses are segregated depending on the federal entities to whom the questions are to be sent. All questions are gathered and sent to the entity for their input.

After, the entities reply, web content is written and translated. Based on this cycle, the following topics were added to the portal in July:

- Labour ban
- Tourist visa
- Trademarks and patents
- Rules for resident visa holders travelling abroad
- Visa amnesty programme
- How to change personal details on Emirates ID.

After the content is added, it is broadcast again on the official social media accounts of the UAE mGovernment.
